



CITI Program Certification guidelines for Coppin Faculty, Students, and IRB members

What is CITI program certification?

The CITI Program [Collaborative Institutional Training Initiative] – is a professional development educational course designed to train researchers and administrators in research, ethics, regulatory oversight, responsible conduct of research, and research administration.

COURSE REQUIREMENT BY TYPE OF RESEARCH

- **Biomedical Research** Investigators conducting research about human biological systems and processes, including efficacy and safety of preventative, diagnostic or therapeutic methods must take this course.
- Social & Behavioral Research Investigators conducting research performed with intent to study behaviors, attitudes, and interactions/social processes among and between individuals, groups, and cultures. Generally, this category of research has no intent of producing a diagnostic, preventative, or therapeutic benefit to the subject who is not seeking nor expecting a health benefit from the research.
- Animal model based Research Investigators conducting research using animal models are required to take courses that meet the U.S. Department of Agriculture (USDA) and Office of Laboratory Animal Welfare (OLAW) requirements for basic training in the humane care and use of animals.
